

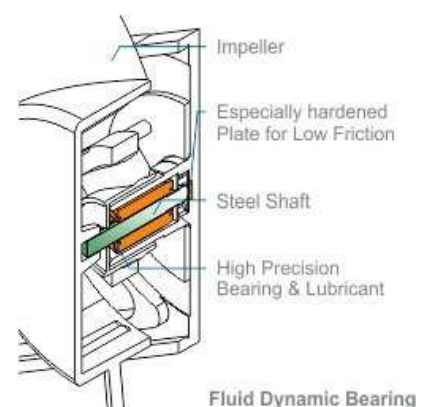


Ultra-quiet fan trays are designed for use in the Penn **R4000 Range** Comms/Server Enclosures.

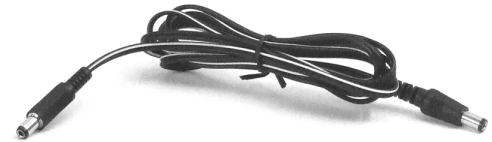
## Thermal Control

A thermal sensor accessory, the **CRC-TEMP** can be plugged into the TEMP socket. It is set to operate at 40° and will reset at 30° + or -2°. Using the acrylic adhesive pad, it should be attached to an area where the sensor can pick up the ambient temperature of the equipment being cooled, and **NOT** directly to the main heat source.
